	- margin	defined on a case-by-case basis, up to 8%
	- upfront fee	defined on a case-by-case basis, up to 4%
3.	Fee for an Annex to the Agreement	PLN 250
4.	Fee for an early repayment - % of the amount being repaid (under the Credit Facility/ Loan, for the Overdraft - % of the granted amount)	up to 2%
5.	Fee for debt balance certificate issued to the Client	PLN 70
6.	Fee for reminder and debt collection activities:	
	- fee for a reminder letter (including due to a failure to ensure a required amount of inflows to the account or due to arrears in the repayment)	PLN 50
	- fee for a reminder letter due to failure to perform additional contractual obligations	PLN 75
7.	Fee for return of a transfer completed upon the Client's request	PLN 20
8.	Fee for a non-standard report or statement prepared upon Client's request – data for up to 3 months	PLN 50
9.	Fee for a non-standard report or statement prepared upon Client's request – data for a period exceeding 3 months	PLN 200
10.	Fee for notification, sent to the Client, of terms of release of collateral for the claims of the Bank	PLN 60
11.	Fee for a different kind of a non-standard letter prepared upon the Client's request	PLN 200

Fees for reminder and debt collection activities will be charged in the first place from the Current Account or the Bank's technical account indicated to the Client. In the case of an Overdraft, the fees may be debited from the Overdraft Account.
